The purpose of this hearing is to secure the views of interested persons concerning the following application for permit:

Application for permit HNW-YFKN-4HT87 under Part 303, Wetlands Protection, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA), by Mr. Craig Schrotenboer, 117 W. 7TH Street, Holland, Michigan 49423. The applicant proposes to fill approximately 0.85 acre of emergent wetland to construct a car shredding facility. The proposed project will also include replacement of two 37-foot long, 48-inch diameter culverts with two 72-foot long, 48-inch diameter culverts to facilitate widening of an access road through wetland and construction of a sediment basin in upland with an Aquip Filtration System and outlets discharging to wetland. The applicant proposes to provide compensatory wetland mitigation by purchasing wetland bank credits. The project is located on Lucy Road in T02N, R05E, Section 06, City of Howell, Livingston County, Michigan.
