

# Info meeting will be Dec. 6 for planned 2023 Grand River rehabilitation, Napier to Wixom

The Road Commission for Oakland County (RCOC), in partnership with the City of Wixom and Lyon Twp., will conduct a public information meeting Tuesday, Dec. 6, about the planned 2023 rehabilitation of Grand River Ave., Napier Road to Wixom Road.

### **MEETING DETAILS**

Date/time: Tuesday, Dec. 6, 4 p.m. to 7 p.m.

<u>Meeting details</u>: The meeting will be open-house format; there will not be a formal presentation. Anyone interested can review plans and talk with RCOC staff at any time during the meeting.

<u>Location</u>: Wixom City Hall, 49045 Pontiac Trail, Wixom, MI 48393.

## **PROJECT DETAILS**

The project will include:

- Pavement milling (grinding off old pavement) and resurfacing Grand River between 12 Mile and Wixom roads.
- Construction of a continuous center left-turn lane between Napier and 12 Mile roads and a mix of resurfacing and reconstruction of this section of Grand River.
- Improvements to drainage and Installation of curbs and gutters.
- Paving of shoulders where appropriate.
- Upgrading pedestrian crosswalks to comply with the Americans with Disabilities Act (ADA).
- Modernization of traffic signals at Grand River/Napier and Grand River/12 Mile intersections.

#### IMPACT ON TRAFFIC

- Two-way traffic will be maintained on Grand River throughout the project.
- Napier Road will be closed at Grand River during one phase of the project for intersection improvements.
- The <u>detour route</u> for Napier traffic during the Napier Road closure will be: Napier Road to 10 Mile Road to



Beck Road to Grand River and vice versa.

#### **S**CHEDULE

- Tree removal will take place in winter and spring of 2023, and will be completed by April 14.
- Road work will begin in late spring of 2023 and be completed in the fall.

# **PROJECT COST AND FUNDING**

The project will cost approximately \$4.9 million and will be paid for with federal funds as well as dollars from RCOC, the City of Wixom and Oakland County general government (through the Tri-Party Program).
