#### PUBLIC COMMENT

Steve Archibald of 57303 Windmill Point of New Hudson he then read a statement. The South Lyon Community Schools aims to support and update the district's facilities and infrastructure to ensure students are able to learn and grow utilizing modern facilities, equipment, and materials. He then stated to support our mission; the Board of Education is asking voters to consider a \$350 million bond proposal that would fund district-wide improvements at a zero-tax increase. The proposal focuses on safety, infrastructure, and providing students with the state-of-the-art technology and future ready learning environments. He further stated they will be having informational meetings in September and October for the public. He further stated, he wanted to provide informational materials in case residents. He further stated, if anyone has any questions, they can contact them at slcs.us/2025-bond-proposal, or call with any questions. It is important for everyone to vote and make an informed decision. Mayor Kennedy asked when the opening of the new pool at the high school will be opening. Mr. Archibald stated it will be

#### **DISCUSSION- Downtown**

City Manager Zelenak stated they are continuing to work on Manager they are continuing to work on the continuing they are continuing to the continuing the continuing the continuing the continuing the continuing th and Pontiac Trail and the first phase is almost complete. Last week the contractor installed the sod for erosion control and future use of the site until the next phase of the projects completed. We are currently waiting for the drinking fountains and the light poles to be delivered. He suggests people keep an eye on the progress that is being made on the site at will almost be ready for immediate use. He then stated we are completing the background checks for the DDA Director and we hope to make an announcement as early as the next Council Meeting. He then reminded everyone that the amended DDA TIF plan public hearing will be held at the next City Council Meeting. He then stated he reached out to DTE regarding the electronic chargers, but has yet to receive a response. He then stated the DDA Board will be discussing applications they have received for the board at the next DDA meeting. Then the appointment will be done at the next Council Meeting. Councilmember Bogert asked if there are sprinklers at the park. City Manager Zelenak stated there is water there but most of the grass that is there now will be removed because it is there now for soil erosion control. There will be turf grass, bushes, trees, shrubs and a lot of brick work will be done on the site. Councilmember Dilg stated the bike racks look great in town and it is a great addition to the downtown. Councilmember Kurtzweil asked for an explanation on the TIF plan Bity Manager Zelenak stated every so many years the TIF plan must be updated by law. The first plan was for 25 years, and now developing the new plan it allows the DDA to set forth ideas and plans to look at what the tax incremental financing dollars will actually be collected within the district so they can start to project into the future what improvements they will be making within the district. Councilmember Kurtzweil asked if it raises taxes. City Manager Zelenak stated it doesn't raise taxes; it's just a plan to show the improvements they plan on making in the future. Councilmember Kiyell stated he was talking with a crossing guard and he was told there was no increase in their pay. City Manager Zelenak stated every year we look at all the rates of pay at the beginning of the year, and he will have to look into this.

#### FIRE CHIEF REPORT

Chief Conrad stated we are at 989 calls and it is trending 25% up from last year. She further stated we've had 40 since August 28th. 26 EMS calls, 3 service calls, 5 false alarms, a vehicle fire, 2 hazardous conditions, and 3 good intent calls. Councilmember Hansen asked if there is a reason there is an uptick in calls. Chief Conrad stated there is an uptick across the state. She stated she thinks people have also figured out they are problem solvers as well, so they don't just call for fires anymore. they call for leaky water heaters, and other things like racoons with cans stuck on their heads. Councilmember Bogert asked if they get many calls with accidents from E-bikes. Chief Conrad said she has not personally. She knows there was one incident when a child fell off his E-Bike on Reynold Sweet and he had a gash in his leg, but there hasn't been an up tick in them. Councilmember Kivell asked if we have a good inventory of the carbon monoxide detectors and smoke detectors. Chief Conrad stated yes, as far as she knows we still

have a good quantity available. She stated we also have some adapters that help with the wired smoke/carbon monoxide detectors. Councilmember Bogert stated on behalf of the South Lyon Youth Assistance, he thanked her and her staff for participating in the back-to-school shopping event.

#### POLICE CHIEF REPORT

Chief Unruh stated the Police Department provided extra patrols for Depot Day as well as the St. Joes Polish event. She further stated the Officers said the food was very good. She also attended and won a gift basket, so it was a good night. She then stated the Officer's are still surveilling the churches, and they are making a high visibility presence at the schools. She then stated our 3 recruits graduated from the academy on Friday of last week, and will be sworn in on Wednesday of this week. They will then have additional training on Thursday and Friday and then start their FTO's this weekend. She further stated they hired an Administrative Coordinator and they are excited about that. The position has been vacant, but they wanted to wait to make sure they hired the right person. She further stated they will start on September 29th. Councilmember Bogert asked if there was an update on the E-bike ordinance. Chief Unruh stated they are still working on it. Councilmember Bogert thanked her on behalf of the South Lyon Youth Assistance for participating in the back-to-school shopping event. Chief Unruh stated she enjoyed it and didn't realize there was such a need out there. She stated they were very nice backpacks, and they were filled with school supplies, and they also gave out paper towel, toilet paper, toothbrushes and toothpaste. It was a lot more than that and the kids were so appreciative and they thanked us. Councilmember Hansen asked about the camera that was installed at 10 mile to monitor traffic, license plates and linked up with other precincts to track data and suspects. Chief Unruh stated she thinks they are still working on the contracts because some of the language was not favorable to the city. Councilmember Kivell asked if she had heard of something about the State considering giving the cities and townships some favor for having some speed limits changed. He further stated he hopes they can research that because there are a lot of people upset about the increase of the speed on some roads.

#### UNFINISHED BUSINESS

1. 2<sup>nd</sup> reading Cross Connection Ordinance

Water and Wastewater Superintendent Beason stated at the August 25th Council meeting we held the first reading to amend the cross-connection ordinance. The South Lyon Water Department has contracted HydroCorp to assist in residential cross connection surveys. Water Dept staff, HydroCorp, and the City Attorney have reviewed the current cross connection ordinance and suggest changes be made to better align with the updated cross connection program rules. He further stated they are requesting to amend Chapter 94, Article II, Section 94-65 cross connections, Section 94-66 enforcement, Section 94-173 continued violation, and add a new Section 94.33 remedies.

City Manager Zelenak stated the city was approached by a property owner at 543 Woodland with a request to annex their property into the City of South Lyon from Lyon Township. Lyon Township consents to the annexation. The attached resolution and agreement outline the detachment of property from Lyon Township into the City of South Lyon. A resolution approving detachment for the negotiated annexation agreement between the Charter Township of Lyon and Kenneth Coleman was approved by the Lyon Township Board at their September 2, 2025 board meeting. Councilmember Kurtzweil asked if the property owner will be covering costs for the city and township for costs. City Manager Zelenak stated they have filed an escrow with the city so that is where the costs will be covered.

#### 2. Chevy Tahoe purchase- Police Dept

Chief Unruh stated they are requesting approval to replace the 2019 Ford Explorer which has 106,455 miles on it and has experienced numerous maintenance issues and is showing signs of significant wear. Ongoing repairs have become costly and disruptive to operations, making it no longer reliable for frontline or support use. This replacement will allow for reassignment of existing vehicles within the department to better align with operational needs. Specifically, the 2022 Ford F-150 and is currently serving as the command vehicle, will be reassigned as the utility vehicle, its original intended use. This truck is more practical for utility functions, particularly for the truck bed can be used for hauling equipment to the range and property to the storage unit at the water treatment plant. The newly purchased vehicle, a 2025 Chevy Tahoe will serve as a patrol vehicle. Current patrol vehicle 553 will now be utilized as a command vehicle. She further stated she received 3 bids and Berger Chevrolet was the lowest. Discussion was held regarding the three quotes.

#### BUDGET

Councilmember Kurtzweil stated there has been a lot of questions since the house side of the budget has been announced. Her concern is the state revenue sharing that comes into the city. She spoke with Chairwomen of the appropriations committee and she explained what it means. What it means is the House has made a proposal where there is about a 12% cut in state revenue. It isn't in stone; it is only the House's proposal. She then explained that is a claw back from the increase from the previous year, it was a one-time grant. She further stated other than that, we will be status quo, but what the house is also proposing that additional funding for roads which will be substantial. She further stated there will be a public safety trust fund and it will be targeted to Police Departments. She then stated there may be other opportunities to get other funds beyond the state finding. She then stated Senator Runestads office sent her the Senate Fiscal Agency out of his side what the state funding would be, and we are showing a decrease in the House side by 3% but the Senate wants to restore it. We will see what happens on September 30th, nothing is in stone. She stated she expressed her concern in any decrease in funding.

#### PUBLIC COMMENT

Linda Benson of 438 Washington stated she is a grandma to her grandson's dog, she visited the Lyon Oaks Dog Park, and it is so big, she thought of McHattie Park. She said as she sits outside on her porch, she sees a lot of dogs on leashes, which is good, but they need to run. She stated she is going to Parks and Recreation as well. She stated there is a lot of land there.

#### **MANAGER'S REPORT**

City Manager Zelenak stated the foundation was poured for the columbarium at the cemetery and we are waiting for the columbarium and there will be a sidewalk poured around it. He then stated the new electronic sign has been installed, and we are awaiting training before we can start doing the messaging. He further stated the County is working with property owners for easements and they are working on eco

permits and water permits for the 2026 Pontiac Trail project. We expecting it to start in March of next year.

Mayor Kennedy reminded everyone that the City Manager's evaluation is due to the City Clerk by Friday the 12<sup>th</sup>.

#### COUNCIL COMMENTS

Councilmember Hansen stated he attended the ribbon cutting ceremony at Venue Next Door and it was well attended. He then congratulated them on opening a new business in downtown South Lyon. He then reminded everyone that Pumpkinfest still needs volunteers.

Councilmember Bogert stated he attended Depot Day and it was well attended and seeing the train going around on the sidewalk was cool. He stated he then went to the Polish Festival at Saint Joe's and it was a great time and the polka band was cool. He then stated the back-to-school shopping event happened, and over 120 kids received backpacks full of school supplies, toiletries, and a gift card for clothes shopping. He then thanked Vibe Credit Union for a financial contribution, St. James Catholic Church for providing backpacks, Meijer for providing discounts for gift cards. Ethos Human Performance, the Coral Family and Missy Garcia. He then thanked Doreen their case worker, Bob who is the chairperson and his cochair for the program Andrea. He then stated Pumpkinfest and South Lyon Live is coming up and they both still need volunteers.

Councilmember Kurtzweil stated this was another incredible weekend for the City of South Lyon, it was packed. She enjoyed the Farmers Market, Depot Day was flooded with a lot of enthusiasm, and it was a great event. She further stated the Cultural Arts Commission was there and people are always requesting to do things with them. It was an incredible event. She further stated the Polish Festival at St. Joe's was extremely well attended, and she met a lot of people that weren't from the South Lyon area, and this was their first visit and they had nothing but positive incredible things to say about how wonderful the community has been. And every time she saw the police, mostly at St. Joes, everyone was talking with them and shaking their hand and thanking them for their service. She further stated the comment that was made was that it was great being in a community that appreciates and respects their Police Officer's. She then thanked all the businesses for donating items for the gift baskets. She then thanked all the volunteers at Depot Day, and at the Polish Festival. She hopes people will volunteer for Pumpkinfest.

Councilmember Kivell stated he went to the park and took some pictures and his mother-in-law moved into the city.

Councilmember Dilg stated she had 9 people staying in her house again, because they were there for the Kensington Disc Golf Tournament and last year, she entered them all in South Lyon and she told them she was going to do it again and they didn't believe her. She stated they went to the Witches Hat and the Hotel on Thursday, the Tiki Bar on Friday, on Saturday they went to the Farmers Market, and shopped at Grande Trunk, Venue Next Door, the Venue, and we went to the ribbon cutting event. She stated she is excited because next year there will be a tournament will be for the word's disc golf event. She stated there will be a lot of people around us and she knows some will go to Brighton and South Lyon, but we should think about some ways to funnel some of the people to our town.

Mayor Kennedy stated On Saturday, September 13, the Youth Entrepreneur Market will take place next to Biggby Coffee from 10am until 3pm. Stop by and see what these young business owners have made and have available for sale. Also, on Saturday and Sunday this weekend, Furry Friends Rescue will be collecting returnable bottles and cans in the Pet Supplies Plus parking lot. They will be there from 11am

until 3pm both days. So, please stop by and drop off your returnables to help this organization continue its great work. He then stated on Saturday; the South Lyon Farmers Market will have a food truck rally with 8 to 10 food trucks available as well as all of the regular market vendors. So, head to the Farmers Market, there's bound to be something there for everyone. Finally, on Saturday September 20 at 9am, the Chamber of Commerce will hold its second Canine Crawl through downtown. There will be giveaways and awards for best costumes, so check out the Lyon Area Chamber of Commerce website for the details.

## CITY OF SOUTH LYON OAKLAND COUNTY, MICHIGAN

### RESOLUTION TO REVISE AND UPATE THE CITY'S CREDIT CARD USE POLICY IN ACCORDANCE WITH PUBLIC ACT 266 OF 1995

WHEREAS the City of South Lyon wishes to use credit cards for the purchase of goods and services for the official business of the City, and

WHEREAS, in accordance with Public Act 266 of 1995, on July 28, 2014, the City adopted a Resolution establishing a credit card use policy consistent with State Law;

WHEREAS, due to administrative personnel changes, the City desires to revise and update its Credit Card Use Policy for the City use and their respective credit limits, and to identify the individual employees authorized to use such credit cards

THEREFORE, BE IT RESOLOVED, that the City of South Lyon hereby revises, updates and adopts the following as its Credit Card Use Policy:

#### CREDIT CARD USE POLICY

- A. The City Manager is responsible for the issuance, accounting, monitoring and retrieval, and generally for the overseeing compliance with the credit card use policy, are as follows:
- B. The authorized City credit cards, as of the adoption of this policy, are as follow:

PNC VISA	\$10,000	City Clerk Lisa Deaton

- C. The City Manager shall notify the City Council regarding the issuance of any additional City credit cards, or an increase of credit limits on any existing credit cards
- D. City credit cards may be used only by those officers or employees authorized and only for the purchase of goods or services for official business of the City of South Lyon. City credit cards shall be used in conformance with the City's purchasing policies.
- E. The officer or employee using any City credit card must submit documentation (e.g.) receipts detailing the goods or services purchased, cost, date of the purchase, and the specific official City business for which it was purchased
- F. The City officer or employee issued or using any City credit card is responsible for its protection and custody and shall immediately notify the City Manager if the card is lost or stolen
- G. Any City officer or employee issued a City credit card must immediately surrender the card upon termination of his or her employment or upon request

- H. The City Treasurer, in conjunction with the affected operating department, shall establish a system of internal controls to monitor the use of any City credit card.
- I. The relevant department head shall approve all credit card purchases and invoices before payment
- J. The balance including interest due on an extension of credit under all credit card arrangements shall be paid not more than 60 days of the initial statement date
- K. Unauthorized or inappropriate use of any City credit card is subject to disciplinary action or measures
- L. The total combined authorized credit limit or all credit cards issued by the City of South Lyon shall not exceed 5% of the total budget of the local unit for the current fiscal year.







AN ORDINANCE TO AMEND CHAPTER58 OF THE CITY OF SOUTH LYON CODE OF ORDINANCES "OFFENSES AND MISCELLANEOUS PROVISIONS", ARTICLE II "OFFENSES AGAINST PUBLIC PEACE", CHAPTER 62 OF THE CITY OF SOUTH LYON CODE OF ORDINANCES "PARKS AND RECREATION", ARTICLE III "USE OF PUBLIC PARKS" AND CHAPTER 90 "TRAFFIC AND VEHICLES", ARTICLE IV "BICYCLES" TO REGULATE THE USE OF ELECTRIC BICYCLES AND ELECTRIC SKATEBOARDS WITHIN THE CITY

#### THE CITY OF SOUTH LYON ORDAINS:

### PART I. AMENDMENT TO CHAPTER 58 OFFENSES AND MISCELLANEOUS PROVISIONS

**Article II, Section 58-124.** "Roller skates, roller blades, street skates and skateboards" is amended as follows:

## Sec. 58-124. - Roller skates, rollerblades, street skates and skateboards and electric skateboards.

The following words, terms and phrases, when used in this division, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning: (a)Definitions. The following words, terms and phrases, when used in this division, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Electric skateboard means a wheeled device that has a floorboard designed to be stood upon when riding that is no more than 60 inches long and 18 including wide, is designed to transport only 1 person at a time, has an electronic propulsion system with power of no more than 2,500 watts, and has a maximum speed on a paved level surface of no more than 25 miles per hour. An electric skateboard may have handlebars and, in addition to having an electrical propulsion system with power of no more than 2,500 watts, may be designed to also be powered by human propulsion. MCL 257.13f.

Roller skates, rollerblades and street skates means a set or series of small wheels on the bottom of a shoe or a frame that would attach to a shoe which are used for gliding on a surface such as a floor or sidewalk, etc.

Skateboards means an item consisting of a short board on small wheels at each end used for coasting and/or for performing athletic stunts.

To roller skate means to skate on any type of roller skates, rollerblades or street skates.

- (b) *Use regulated*. It shall be unlawful for any person to roller skate or use a skateboard(s) within the city without complying with the terms of this section.
- (c) Riding on certain devices or structures. It shall be unlawful to roller skate or ride on a skateboard or electric skateboard on any bench, table, planter wall, retaining wall or other device or structure which is not intended for pedestrian or vehicle traffic, or to jump or step on or off such devices or structures in the process of roller skating or riding a skateboard. Riding of electric skateboards shall be prohibited in the central and historic districts.
- (d) *Riding prohibited where posted.* The city manager is hereby authorized to erect signs on any publicly owned parking area, street, sidewalk, parking structure, parking lot, or other public property prohibiting roller skating, the riding of skateboards or electric skateboards thereon. It shall be unlawful to roller skate or ride a skateboard on any such posted parking area, street, sidewalk, parking structure, parking lot or other public property.
- (e) Reckless or dangerous skating or riding. It shall be unlawful for any person to roller skate or ride a skateboard or electric skateboard on any sidewalk or other paved surface intended for pedestrians in a reckless or careless manner, or in a manner which is likely to result in injury or harm to any person or property.
- (f) *Riding on private property without permission*. It shall be unlawful for any person to roller skate or ride a skateboard or electric skateboard on private property that has been posted no skateboarding.
- (g) *Penalty for violation of section*. Any person who violates any of the provision of this division shall be responsible for a municipal civil infraction.

#### PART II. AMENDMENT TO CHAPTER 62 PARKS AND RECREATION

Article III, Section 62-61. "Definitions" is amended to add the following definition:

*Electric bicycle* means a device upon which an individual may ride that satisfies all of the following:

- (a) The device is equipped with all of the following:
- (i) A seat or saddle for use by the rider.
- (ii) Fully operable pedals for human propulsion.
- (iii) An electric motor of not greater than 750 watts.
- (b) The device falls within 1 of the following categories:
- (i) Class 1 electric bicycle means an electric bicycle that is equipped with an electric motor that provides assistance only when the rider is pedaling and that disengages or ceases to function when the electric bicycle reaches a speed of 20 miles per hour.

- (ii) Class 2 electric bicycle means an electric bicycle that is equipped with a motor that propels the electric bicycle to a speed of no more than 20 miles per hour, whether the rider is pedaling or not, and that disengages or ceases to function when the brakes are applied.
- (iii) Class 3 electric bicycle means an electric bicycle that is equipped with a motor that provides assistance only when the rider is pedaling and that disengages or ceases to function when the electric bicycle reaches a speed of 28 miles per hour.

Electric skateboard means a wheeled device that has a floorboard designed to be stood upon when riding that is no more than 60 inches long and 18 including wide, is designed to transport only 1 person at a time, has an electronic propulsion system with power of no more than 2,500 watts, and has a maximum speed on a paved level surface of no more than 25 miles per hour. An electric skateboard may have handlebars and, in addition to having an electrical propulsion system with power of no more than 2,500 watts, may be designed to also be powered by human propulsion. MCL 257.13f.

Article III, Section 62-63 "Use of Public Parks," is amended to read as follows:

#### Sec. 62-63. - Use and parking of vehicles and electric bicycles and electric skateboards

It shall be unlawful to drive or operate a vehicle in areas other than designated roadways and parking areas existing, maintained, and designated as such. It shall also be unlawful for any vehicle to exceed posted speed limits within such a park. Any person who operates a vehicle in violation of this section is responsible for a civil infraction

It shall be lawful to operate a class 1, class 2 or class 3 electric bicycle and an electric skateboard on a linear trail that has an asphalt, crushed limestone, or similar surface. Riders of electric bicycles and electric skateboards shall yield to the right of way to pedestrians, bicycles, and other human-powered conveyances. A person under the age of fourteen shall not operate a class 3 electric bicycle. It shall be unlawful to operate an electric bicycle or electric skateboard on a trail that is specifically designed as nonmotorized and that has a natural surface tread that is made by clearing and grading of native soil and has no added hard surfacing materials. An individual less than 18 years of age who operates or rides as a passenger on a class 3 electric bicycle shall wear a properly fitted and fastened bicycle helmet that meets federal standards established under federal law, including standards adopted by the United States Consumer Product Safety Commission.

It shall be a misdemeanor for person to operate an electric bicycle or electric skateboard in violation of this section. A violation shall be punished by a fine of not more than \$100.00, or by imprisonment of not more than 90 days, or both.

**Article III, 62-74** "Trailway regulations and prohibitions" be amended to add a new subsection (j) for electric bicycles to read as follows:

#### Sec. 62-74. - Trailway regulations and prohibitions

#### (a)-(i) Unchanged

- (j) *Electric bicycles* No person shall operate an electric bicycle on a trailway in a careless or reckless manner and shall not operate an electric bicycle in excess of ten (10) miles per hour.
- (k) *Electric skateboard* No person shall operate an electric skateboard on a trailway in a careless or reckless manner and shall not operate an electric bicycle in excess of ten (10) miles per hour.

#### PART III AMENDMENT TO CHAPTER 90 TRAFFIC AND VEHICLES

**Article IV-BICYCLES Sec. 90-131**"General Traffic laws" is amended to add requirements for electric bicycles as follows:

#### Sec. 90-131. - General traffic laws.

- (a) Every person riding a bicycle or electric bicycle upon a roadway shall be granted all of the rights and shall be subject to all of the responsibilities applicable to the driver of a motor vehicle by the laws of this state declaring rules of the road applicable to motor vehicles or by article II of this chapter applicable to the driver of any vehicle, except as to special regulations in this article and except as to those provisions of law and article II of this chapter which by their nature can have no application.
- (b) Any person operating a bicycle or electric bicycle shall obey the instructions of official traffic control signals, signs and other traffic control devices applicable to motor vehicles, unless otherwise directed by a police officer.
- (c) No person shall park a bicycle or electric bicycle upon a street other than upon the roadway against the curb or upon the sidewalk in a rack to support the bicycle or against a building, or in such manner as to afford the least obstruction to pedestrian traffic.
- (d) Whenever any person is riding a bicycle upon a sidewalk, such person shall yield the right-of-way to any pedestrian and shall give an audible signal before overtaking and passing such pedestrian. As provided in the Michigan Vehicle Code, electric bicycles are not permitted to ride on sidewalks.
- (e) Every bicycle or electric bicycle when in use at nighttime shall be equipped with a lamp on the front which shall emit a white light visible from a distance of at least 500 feet to the front and with a red reflector on the rear, of a type which shall be visible from all distances from 50 feet to 300 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle.
- (f) Every bicycle and electric bicycle shall be equipped with a brake which will enable the operator to make the braked wheel skid on dry, level, clean pavement.
- (g) It shall be prohibited to ride electric bicycles in the historic or central business district.
- (h) Riding prohibited where posted. The city manager is hereby authorized to erect signs on any publicly owned parking area, street, sidewalk, parking structure, parking lot, or other public property prohibiting the riding of electric bicycles thereon. It shall be unlawful to ride an electric bicycle on any such posted parking area, street, sidewalk, parking structure, parking lot or other public property.

Article IV-BICYCLES Sec. 90-132 Registration shall be deleted in its entirety.

**Article IV-BICYCLES Sec. 90-133** Rental agencies shall be deleted in its entirety. **Part V. – Severability.** If one or more sections, provisions, phrases or words of this Ordinance are declared to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, this Ordinance is declared to be severable.

**PART VI.** Savings Clause. The amendment of the City of South Lyon Code of Ordinances set forth in this Ordinance does not affect or impair any act done, offense committed, or right accruing, accrued, or acquired or liability, penalty, forfeiture or punishment, pending or incurred prior to the amendment of the South Lyon Code of Ordinances set forth in this Ordinance.

**PART VII.** Repealer. All other Ordinances or parts of Ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

**PART VII. Effective Date: Publication.** The provisions of this Ordinance shall become effective fifteen (15) days after its adoption and shall be published within fifteen (15) days of its adoption by publication of a brief notice in a newspaper circulated in the City, stating the date of enactment and the effective date of the ordinance, a brief statement as to the subject matter of this Ordinance and such other facts as the Clerk shall deem pertinent, and that a copy of the Ordinance is available for public use and inspection at the office of the City Clerk.

#### **CONSENT JUDGMENT**

At a session of said Court, held in the City of Novi, County of Oakland, State of Michigan On September \_\_\_, 2024

This matter comes before the Court upon the stipulation of the Parties; the Parties to this Consent Judgment having agreed to settle this dispute as reflected in this Consent Judgment, which Consent Judgment is deemed to incorporate all exhibits attached hereto; each of the Parties to this Consent Judgment having represented that all requirements necessary for the party to bind itself

to this Consent Judgment have been met; and the Court being otherwise fully advised in the premises:

- 1. Plaintiff/Counter-Defendant City of South Lyon ("City") is the owner of real property located in South Lyon, Oakland County, Michigan, as described in attached Exhibit A (the "Property").
  - 2. The City purchased the Property on or about October 25, 2007.
- 3. Defendant/Counter-Plaintiff Adams Outdoor Advertising Limited Partnership ("Adams") entered into a Lease Agreement to place a billboard on the Property with the Property's previous owner, Bonnie C. Niece, on November 23, 2004 ("Lease"). The Lease is attached as Exhibit B.
- 4. Adams' Lease was assigned to the City of South Lyon on or about October 25, 2007.
- 5. The City filed this action for breach of contract, declaratory judgment, trespass, conversion, quiet title, and seeking to evict Adams from the Property.
- 6. Adams filed counterclaims for breach of contract, declaratory judgment, and inverse condemnation.

The parties now desire to settle this lawsuit and their respective claims against each other in accordance with the terms and conditions set forth in this Consent Judgment.

#### NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

- A. Adams' Lease on the Property is extended for five (5) years without any option for renewal, and the Lease shall terminate on March 31, 2030.
- B. No later than April 30, 2030, Adams shall remove the billboard structure and repair any

- damage caused to the Property, including, but not limited to, repairing the lawn by leveling and seeding.
- C. The rental amount during the extended lease term will be \$650 per year.
- D. The side of the billboard facing South shall be used exclusively for the display of one public service advertisement provided by the Ad Council. Adams must provide the proposed Ad Council advertisement to the City Manager for approval prior to placement or any replacement of said advertisement. Such advertisement shall be placed within thirty (30) days of entry of this Consent Judgment and shall be maintained in good condition until the expiration of the five (5) year term. Examples of the advertisements are those identified in Exhibit C, which is incorporated herein by reference. No other advertising shall be displayed on the side of the billboard facing South.
- E. The parties agree that the following portion of Lease Paragraph 9 shall be deemed stricken from the Lease as of the date of entry of this Consent Judgment:
  - "...with the exception of any termination rights of Lessor set forth in the Lease Agreement or any addendum or subsequent amendment, which rights may only be exercised by the original Lessor (whose name is set forth at the top of this lease) and not by or for the benefit of any entity with the power of eminent domain."
- F. All remaining provisions of the Lease, except as altered by the above terms and conditions, remain in full force and effect.
- G. The terms of this Consent Judgment may only be amended, modified, or altered by written agreement of the parties and approval by the Court.
- H. Subject to the terms and provisions of this Consent Judgment, all claims and causes of action that were alleged or which could have been alleged by the City or Adams in this

lawsuit shall be and hereby are merged into this Consent Judgment, fully released, and dismissed with prejudice and without cost or attorney fees to any party.

I. The Court retains jurisdiction to enforce the terms of this Consent Judgment.

#### SO ORDERED AND ADJUDGED.





Re: City Update

**2026 Pontiac Trail Road Project:** The \$11 million project begins next spring. Easements are being obtained, and permits are also being worked on with various agencies. The cost to the city for the entire project will be approximately \$1.3 million dollars.

**Columbarium:** The concrete foundation for the columbarium has been poured. We will await the delivery of the actual columbarium (after the concrete cures). After which we will pour the remaining sidewalk in and around the site.

Lafayette Park: They continue to work on the new Lafayette Park at the corner of McHattie St and Pontiac Trail. They have almost completed the first phase of the project. The contractor installed sod yesterday for future use, as well as for soil erosion control until the next phase of the project is completed. We await the delivery of the light poles and the drinking fountain. This initial phase will make it available for almost immediate use.

**9 Line Project:** On an upcoming City Council agenda in October I will be bringing to City Council the Memorandum of Understanding for the Oakland County Nine Mile Pathway Phase II Task Force. This is a non-binding agreement which shows our cooperation and participation in this pathway project. The other communities will also be bringing the MOU to their council / board for their approval as well. We will have representatives of Oakland County at the meeting to answer questions.

**DTE Chargers:** The chargers have all been prepped and energized. We await their connection to the WIFI for them to become operational.

**DDA:** Our new DDA / Economic Development Director (Kim Rivera) will be starting on Monday, September 22<sup>nd</sup>. She will be in attendance at the meeting. Her first full report will be coming at the next City Council meeting.

Pumpkinfest: The event will be held next weekend on September 26th, 27th and 28th

**Audit Presentation:** The Auditors will be in attendance at our October 13<sup>th</sup> City Council meeting to discuss and present this years Audit.

138 S. Lafayette: As you may know, the City owns the property at 138 S. Lafayette and Liberty, which is currently used as a City parking lot. The property was formerly a gas station, and the former property owner has been working with EGLE on remediation. Recently, we received communication from a representative of the former property owner requesting the City agree to restrict use of the property by the execution and recording of a restrictive covenants which would, in summary: prohibit use of the property as a residence; restrict groundwater use; and require compliance with EGLE regulations for the construction of buildings on the property. However, after discussions with the City Attorney and EGLE we learned that there are alternatives to remediation including excavation of the southern portion of the property, or collection of more soil gas samples to see if we get better results or waiting for the concentrations to continue to decline naturally. Since there are alternatives that will not encumber the City's property, we declined to consider the restrictive covenant option. If Council would like to discuss this issue further, please let me know and we can put it on a future agenda.
