Call to the Public:

1. Public Comment is limited to Call to the Public section on the agenda.
2. Call to the Public is limited to three (3) minutes per speaker, unless otherwise determined by the Township Board based on the number of persons wishing to speak.
3. Written material should be presented to the Township Board rather than read if it would exceed the 3-minute limit.
4. Comments and questions are to be addressed to the Chairperson, rather than to other individuals in the audience.

Citizen Participation during Electronic Meetings:

During Township Board meetings conducted electronically, members of the public attending the meeting, once recognized by the chair, shall identify themselves for the record and indicate whether they are a Township resident. Comments by the public will be limited in the same manner as provided for audience comment for non-electronic meetings to three minutes for each speaker unless the time is extended by the chair or by vote of the Board. Comments by the public during meetings held electronically will be limited to the Audience Comment portion of the meeting.

Public Hearing:

1. Comment is limited to three (3) minutes per speaker, unless otherwise determined by the Township Board based on the number of persons wishing to speak.
2. Written material should be presented to the Township Board rather than read if it would exceed the three (3) minute limit.
3. Comments and questions are to be addressed to the Chairperson, rather than to other individuals.

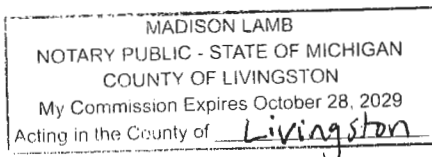

**RESOLUTION NUMBER 06-2026
RESOLUTION AUTHORIZING ISSUANCE OF
SPECIAL ASSESSMENT BONDS, SERIES 2026
(TAXABLE)**

WHEREAS, pursuant to Act No. 188, Public Acts of Michigan, 1954, as amended, the necessary proceedings have been taken for the acquisition, construction and installation of improvements to roads and related, ancillary and appurtenant facilities within the Oakwood Meadows and Oakwood Meadows #2 subdivisions on Daleview Drive, Sequoia Lane, Ponderosa Drive, Atwood Drive, Larch Lane, Sumac Lane, and Ten Mile Road and related, ancillary and appurtenant improvements in the Oakwood Meadows Road Improvements Special Assessment District in the Township, and to defray the cost thereof special assessments have been made against lands in the Oakwood Meadows Road Improvements Special Assessment District (the "District"); and

WHEREAS, the Township Board previously confirmed the Oakwood Meadows Road Improvements Special Assessment Roll for the District in the aggregate amount of \$1,234,645.40 and specified the dates on which the installments of assessments would become due; and

WHEREAS, the Township Board desires to issue the bonds of the Township as hereinafter described to finance the improvements, which bonds shall be secured in the first instance by the special assessments against the lands in the District; and

WHEREAS, the special assessments made on the Oakwood Meadows Road Improvements Special Assessment Roll for the District and outstanding on the date hereof have been divided into ten (10) approximately equal annual installments, the first installment being due February 14, 2027, and the subsequent installments being due consecutively on February 14 in each of the years 2028 through 2041, in each case together with interest on installments from time to time remaining unpaid at a rate not to exceed 1% above the average interest rate borne by bonds issued to finance the improvements; and

WHEREAS, the improvements will provide benefit and value to the Township and its residents as evidenced by increased accessibility for the public throughout the special assessment district, inasmuch as the roads therein are open to the public and increased access for public safety services such as police protection, fire protection and other emergency or municipal services.

THEREFORE, BE IT RESOLVED by the Township Board of Green Oak Charter Township, Livingston County, Michigan, as follows:

1. **AUTHORIZATION OF BONDS - PURPOSE.** Bonds of the Township shall be issued in the aggregate principal sum of not to exceed Nine Hundred Seventy-Seven Thousand Four Hundred Twenty-Seven Dollars (\$977,427) in anticipation of the collection of an equal amount of installments of assessments against lands in the Oakwood Meadows Road Improvements Special Assessment District to defray the cost of the acquisition, construction and installation of road improvements in such district. It is hereby determined that there is sufficient public benefit and value to the Township and its residents as described in the preamble hereto for the pledge of the full faith and credit of the Township as additional security for the payment of principal of and interest on the bonds as hereinafter described. Each of the Supervisor, Clerk, or Treasurer, acting individually, is hereby designated as an "Authorized Officer" for purposes of this resolution.

2. **BOND DETAILS.** The bonds shall be designated "Special Assessment Bonds, Series 2026 (Taxable)", or as otherwise designated by the Authorized Officer; shall be dated the date of their delivery; shall be issued in such aggregate principal amount as determined by the Authorized Officer; shall be numbered consecutively from 1 upwards; shall be fully registered; shall be in any denomination not exceeding the aggregate principal amount for each maturity at the option of the purchaser thereof; shall bear interest at a rate or rates not exceeding 6% per annum to be determined upon the sale thereof and payable on such dates as shall

be determined by order of the Authorized Officer; and shall be serial and/or term bonds and mature on such dates and in such amounts as shall be determined by order of the Authorized Officer; provided, however, that the final principal maturity of the bonds shall be not later than June 1, 2041. If the original purchaser of the bonds shall designate certain of the bonds as term bonds, the principal maturities of the bonds shall become mandatory redemption requirements in accordance with the provisions of Section 7 and the form of bond set forth in Section 11. If requested by the original purchaser of the bonds and determined by the Authorized Officer, the bonds may be issued in the form of a single bond with an exhibit containing the principal maturity amounts and applicable interest rates and due dates.

3. **METHOD OF SALE.** The bonds shall be sold pursuant to a negotiated sale or private placement at a price not less than 99% of their par value and as further provided in this resolution. The Authorized Officer shall request or shall cause the request of one or more proposals or quotes for the purchase of the bonds from financial institutions to be determined after consultation with MFCI, LLC, the Township's registered municipal advisor for the bonds. After the receipt of bids, quotes, or proposals, the Authorized Officer, if determined that it is in the best interest of the Township to do so, shall enter an order awarding the bonds to the bidder whose bid produces the lowest true interest cost. The Authorized Officer is further authorized to negotiate, execute and deliver a term sheet or placement agreement in addition to or in place of an order to effectuate the sale of the bonds, if and as necessary. It is hereby determined that this method of sale is in the best interests of the Township and is calculated to provide the Township with flexibility in the timing of the sale of the bonds and the lowest costs of borrowing money through the issuance of the bonds.

4. **PAYMENT OF PRINCIPAL AND INTEREST.** The principal of and interest on the bonds shall be payable in lawful money of the United States. Principal shall be payable upon presentation and surrender of the bonds to the bond registrar and paying agent as they severally mature; provided, however, the Authorized Officer may determine by order that presentation and surrender of the bonds to the bond registrar and paying agent are not required for payment of some or all of the principal installments, and in such case such principal installments shall be paid to the registered owner of the bonds as shown on the registration books. Interest shall be paid to the registered owner of each bond as shown on the registration books at the close of business on the 15th day of the calendar month preceding the month in which the interest payment

is due. Interest shall be paid when due by wire transfer or other electronic means, or check or draft mailed by the bond registrar and paying agent to the registered owner at the registered address.

5. **BOOK-ENTRY SYSTEM.** If requested by the original purchaser of the bonds and determined by the Authorized Officer to be in the best interest of the Township, initially, one fully-registered bond for each maturity, in the aggregate amount of such maturity, shall be issued in the name of Cede & Co., as nominee of The Depository Trust Company ("DTC") for the benefit of other parties (the "Participants") in the book-entry-only transfer system of DTC. In the event the Township determines that it is in the best interest of the Township not to continue the book-entry system of transfer or that the interests of the holders of the bonds might be adversely affected if the book-entry system of transfer is continued, the Township may notify DTC and the bond registrar and paying agent, whereupon DTC will notify the Participants of the availability through DTC of bond certificates. In such event, the bond registrar and paying agent shall deliver, transfer and exchange bond certificates as requested by DTC and any Participant or "beneficial owner" in appropriate amounts in accordance with this Resolution. DTC may determine to discontinue providing its services with respect to the bonds at any time by giving notice to the Township and the bond registrar and paying agent and discharging its responsibilities with respect thereto under applicable law or the Township may determine that DTC is incapable of discharging its duties and may so advise DTC. In either such event, the Township shall use reasonable efforts to locate another securities depository. Under such circumstances (if there is no successor securities depository), the Township and the bond registrar and paying agent shall be obligated to deliver bond certificates in accordance with the procedures established by this resolution. In the event bond certificates are issued, the provisions of this resolution shall apply to, among other things, the transfer and exchange of such certificates and the method of payment of principal of and interest on such certificates. Whenever DTC requests the Township and the bond registrar and paying agent to do so, the Township and the bond registrar and paying agent shall cooperate with DTC in taking appropriate action after reasonable notice to make available one or more separate certificates evidencing the bonds to any Participant having bonds certified to its DTC account or to arrange for another securities depository to maintain custody of certificates evidencing the bonds.

Notwithstanding any other provision of this resolution to the contrary, so long as any bond is registered in the name of Cede &

Co., as nominee of DTC, all payments with respect to the principal of, interest on and redemption premium, if any, on such bonds and all notices with respect to the bonds shall be made and given, respectively, to DTC. The Authorized Officer or the Treasurer is authorized to sign the Blanket Issuer Letter of Representations on behalf of the Township, in such form as such officer deems necessary or appropriate in order to accomplish the issuance of the bonds in accordance with law and this resolution.

Notwithstanding any other provision of this resolution to the contrary, if the Authorized Officer deems it to be in the best interest of the Township, the bonds shall not initially be issued through the book-entry-only transfer system of DTC.

6. **OPTIONAL REDEMPTION.** The bonds shall be subject to optional redemption prior to maturity upon such terms and conditions as shall be determined by order of the Authorized Officer.

7. **MANDATORY PRIOR REDEMPTION.** If any of the bonds are designated by the original purchaser as term bonds, such bonds shall be subject to mandatory prior redemption at par and accrued interest in accordance with the maturity schedule determined by the Authorized Officer and upon the terms and conditions set forth in the form of bond contained in Section 11 hereof. The bonds to be redeemed shall be selected by lot.

8. **BOND REGISTRAR AND PAYING AGENT.** The Authorized Officer shall designate, and may enter into an agreement with, a bond registrar and paying agent for the bonds, which shall be a bank or trust company located in the State of Michigan that is qualified to act in such capacity under the laws of the United States of America or the State of Michigan. The Authorized Officer may from time to time as required designate a similarly qualified successor bond registrar and paying agent. Alternatively, the Treasurer may serve as bond registrar and paying agent for the bonds if the Authorized Officer determines it is in the best interest of the Township.

9. **EXECUTION, AUTHENTICATION AND DELIVERY OF BONDS.** The bonds shall be executed in the name of the Township by the manual or facsimile signatures of the Supervisor and Township Clerk and authenticated by the manual signature of an authorized representative of the bond registrar and paying agent; provided, however, that manual authentication shall not be required for bonds for which the Township Treasurer shall serve as the bond registrar and paying agent. After the bonds have been executed and authenticated for delivery to the original purchaser thereof, they

shall be delivered by the Authorized Officer or the Treasurer to the purchaser upon receipt of the purchase price. Additional bonds bearing the manual or facsimile signatures of the Supervisor and Clerk may be delivered to the bond registrar and paying agent for authentication and delivery in connection with the exchange or transfer of bonds. The bond registrar and paying agent shall indicate on each bond the date of its authentication.

10. **EXCHANGE AND TRANSFER OF BONDS.** Any bond, upon surrender thereof to the bond registrar and paying agent with a written instrument of transfer satisfactory to the bond registrar and paying agent duly executed by the registered owner or his duly authorized attorney, at the option of the registered owner thereof, may be exchanged for bonds of any other authorized denominations of the same aggregate principal amount and maturity date and bearing the same rate of interest as the surrendered bond.

Each bond shall be transferable only upon the books of the Township, which shall be kept for that purpose by the bond registrar and paying agent, upon surrender of such bond together with a written instrument of transfer satisfactory to the bond registrar and paying agent duly executed by the registered owner or his duly authorized attorney.

Upon the exchange or transfer of any bond, the bond registrar and paying agent on behalf of the Township shall cancel the surrendered bond and, subject to Section 9 above, shall authenticate and deliver to the transferee a new bond or bonds of any authorized denomination of the same aggregate principal amount and maturity date and bearing the same rate of interest as the surrendered bond. If, at the time the bond registrar and paying agent authenticates and delivers a new bond pursuant to this section, payment of interest on the bonds is in default, the bond registrar and paying agent shall endorse upon the new bond the following: "Payment of interest on this bond is in default. The last date to which interest has been paid is [appropriate date to be inserted, if necessary]."

The Township and the bond registrar and paying agent may deem and treat the person in whose name any bond shall be registered upon the books of the Township as the absolute owner of such bond, whether such bond shall be overdue or not, for the purpose of receiving payment of the principal of and interest on such bond and for all other purposes, and all payments made to any such registered owner, or upon his order, in accordance with the provisions of section 4 of this resolution shall be valid and effectual to satisfy and discharge the liability upon such bond to the extent of the sum or sums so paid, and neither the Township

This bond is transferable, as provided in the Resolution, only upon the books of the Township kept for that purpose by the bond registrar and paying agent, upon the surrender of this bond together with a written instrument of transfer satisfactory to the bond registrar and paying agent duly executed by the registered owner or his attorney duly authorized in writing. Upon the exchange or transfer of this bond a new bond or bonds of any authorized denomination, in the same aggregate principal amount and of the same interest rate and maturity, shall be authenticated and delivered to the transferee in exchange therefor as provided

12. **SECURITY.** The principal of and interest on the bonds shall be payable primarily out of the collections of the special assessments in anticipation of which they are issued, but the full faith and credit of the Township also are pledged to the payment of such principal and interest. If the receipts from the special assessments in anticipation of which the bonds are issued shall not be sufficient to pay such principal and interest as the same shall become due, then an amount sufficient to pay the deficiency shall be advanced from the general fund of the Township. The Township's ability to raise such funds is subject to applicable constitutional and statutory tax limitations on the taxing power of the Township.

13. **DEFEASANCE.** In the event cash or direct obligations of the United States or obligations the principal of and interest on which are guaranteed by the United States, or a combination thereof, the principal of and interest on which, without reinvestment, come due at times and in amounts sufficient to pay, at maturity or irrevocable call for earlier optional redemption, the principal of, premium, if any, and interest on the bonds, shall have been deposited in trust, this resolution shall be defeased and the owners of the bonds shall have no further rights under this resolution except to receive payment of the principal of,

premium, if any, and interest on the bonds from the cash or securities deposited in trust and the interest and gains thereon and to transfer and exchange bonds as provided herein.

14. **ESTIMATES OF PERIOD OF USEFULNESS AND COST.** The estimated period of usefulness of the improvements for which said bonds are to be issued is hereby determined to be 10 years and upwards, and the estimated cost thereof in the amount of \$1,234,645.40 is hereby approved and adopted.

15. **PRINCIPAL AND INTEREST FUND.** There shall be established for the said bonds a Principal and Interest Fund that shall be kept in a separate bank account; provided, however, that such fund may be pooled or combined for deposit or investment purposes only with other Township debt retirement funds created for special assessment debt. From the proceeds of the sale of the bonds there shall be set aside in the Principal and Interest Fund any premium and accrued interest received from the purchaser of the bonds at the time of delivery. All collections (including principal, interest and penalties) on the special assessments in anticipation of the collection of which the bonds are issued shall be placed in the Principal and Interest Fund and so long as the principal of or interest on any of the bonds shall remain unpaid, no moneys shall be withdrawn from such fund except to pay such principal and interest.

16. **CONSTRUCTION FUND.** The remainder of the proceeds of the sale of the bonds, together with an amount determined by the Authorized Officer from the collection of installments of the assessments on the Oakwood Meadows Road Improvements Special Assessment Roll for Oakwood Meadows Road Improvements Special Assessment District, shall be set aside in a construction fund and used to acquire and construct the improvements heretofore described including any engineering, legal, and other expenses incidental thereto. Any unexpended proceeds of the sale of the bonds remaining after completion of the construction of the improvements shall be deposited in the Principal and Interest Fund.

17. **REPLACEMENT OF BONDS.** Upon receipt by the Treasurer of proof of ownership of an unmatured bond, of satisfactory evidence that the bond has been lost, apparently destroyed or wrongfully taken and of security or indemnity that complies with applicable law and is satisfactory to the Treasurer, the Treasurer may authorize the bond registrar and paying agent to deliver a new executed bond to replace the bond lost, apparently destroyed or wrongfully taken in compliance with applicable law. In the event an outstanding matured bond is lost, apparently destroyed or wrongfully taken, the Treasurer may authorize the bond registrar

and paying agent to pay the bond without presentation upon the receipt of the same documentation required for the delivery of a replacement bond. The bond registrar and paying agent, for each new bond delivered or paid without presentation as provided above, shall require the payment of expenses, including counsel fees, which may be incurred by the bond registrar and paying agent and the Township in the premises. Any bond delivered pursuant the provisions of this section 17 in lieu of any bond lost, apparently destroyed or wrongfully taken shall be of the same form and tenor and be secured in the same manner as the bond in substitution for which such bond was delivered.

18. **SALE, ISSUANCE, DELIVERY, TRANSFER AND EXCHANGE OF BONDS.** The Authorized Officer is authorized to determine the date for the sale of the bonds and to do all things necessary to effectuate the sale, issuance, delivery, transfer, and exchange of bonds in accordance with this resolution. The Supervisor, the Treasurer, the Clerk, and all other officials of the Township are also authorized to do all things necessary to effectuate the sale, issuance, delivery, transfer, and exchange of bonds in accordance with this resolution.

19. **TAXABLE OBLIGATIONS.** The interest on the bonds is included in gross income for federal income tax purposes.

20. **REDUCTION OF PRINCIPAL AMOUNT OF BONDS.** In the event that the Authorized Officer determines that it is not necessary for the Township to issue bonds in the aggregate principal amount set forth in section 1 of this resolution, the Authorized Officer is authorized to reduce such amount by executing a written order that sets forth the new aggregate principal amount of the bonds and designates new principal maturity amounts in lieu of the principal maturity amounts set forth in section 2 hereof. In such case, the form of the bonds set forth in this resolution shall be modified accordingly.

21. **PROFESSIONAL SERVICES.** Dickinson Wright PLLC is hereby appointed to act as bond counsel and MFCI, LLC is hereby appointed to act as municipal advisor with respect to the bonds.

AGREEMENT FOR OPERATION AND MAINTENANCE
GREEN OAK TWP WWTP / SEWER

This is an Agreement, made on this day March 1, 2026, by and between **GREEN OAK TWP WWTP / SEWER**, hereinafter called the Owner and **HIGHLAND TREATMENT CO., INC** a Michigan Corporation of Highland, Michigan, hereinafter called Highland.

WHEREAS Owner wishes to employ HIGHLAND to provide services for the GREEN OAK TWP WWTP / SEWER Wastewater Facility, to serve as Owner's representative and to provide monthly operational services for the wastewater facility hereinafter called the Facility.

NOW, Therefore, Owner and HIGHLAND in consideration of their mutual covenants herein agree in respect to the performance of services by HIGHLAND and the payment for those services by Owner, as set forth below.

SECTION 1

SERVICES OF HIGHLAND

- 1.1 HIGHLAND will provide the following services at the above stated Facility:
- 1.2 Routine operation and maintenance of the Facility on a five days per week basis as required by the State of Michigan Groundwater Discharge **Permit No .** Routine operation and maintenance do not include capital improvements or the repair or replacement of tanks, piping, valves, electrical controls, generators or other similar repairs ("Exempt Repairs"), which remain the responsibility of the owner. **Highland Treatment may check fluids and fuel of any on-site generators, but it is not a requirement.** Highland will assist in efforts to procure bids for Exempt Repairs.
- 1.3 HIGHLAND's obligations under the Agreement do not include non-routine operation and maintenance, including service required as a result of flood, fire, act of God, other force of nature, or as a result or related to any causes described in section 7.1 below. At Owner's request, HIGHLAND will assist the Owner in obtaining services required as a result of such events with compensation to HIGHLAND provided on the basis of per diem callout rates plus expenses.
- 1.4 Provide Saturday, Sunday and Holiday operation and maintenance if requested by the Owner on a time and material basis. Such call-outs cost \$100 per hour plus

\$.70 per mile portal to portal. Similarly, emergency or unscheduled call-outs cost \$100 per hour plus \$.70 per mile portal to portal.

- 1.5 Provide and assume responsibility for staffing of required operators and maintenance personnel to provide routine operation and maintenance of the Facility.
- 1.6 Provide the Owner and Owner's representatives with a list of phone numbers to call in the event of an emergency.
- 1.7 Provide the Owner with any maintenance and operational records pertaining to the Facility, including sampling and laboratory analyses performed in connection with the requirements of regulatory agencies and/or the Permit. Records may be provided to the Owner upon request.
- 1.8 Provide the Owner or Owner's representative with assistance when discussing this system with the State, County, or Township regarding the operations or maintenance of this Facility.
- 1.9 HIGHLAND will provide and maintain throughout the term of the Agreement Workers Compensation insurance with a limit of \$500,000 and Comprehensive General Liability Insurance. HIGHLAND will furnish Owner with Certificate of Insurance as evidenced that policies providing the required coverage and limits are in full force and effect for the term of the Agreement.

SECTION 2

OWNER'S RESPONSIBILITIES

- 2.1 Owner agrees to timely perform each of the following obligations:
- 2.2 Pay HIGHLAND for all services performed under the Agreement in accordance with Section 3 below.
- 2.3 Maintain in effect all guarantees, warranties, easements, permits, licenses, and other approvals and consents received or required as Owner of the Facility.
- 2.4 Identify and pay for any and all (a) capital improvements to Facility as may be required, (b) replacement of Facility structures, and (c) Exempt Repairs.

- 2.5 Provide prompt review of HIGHLAND recommendations for equipment replacement, capital improvements, or repairs to the Facility, including Exempt repairs.
- 2.6 Maintain and pay for any and all utilities used in connection with the Facility.
- 2.7 Maintain in safe and good working order the premises surrounding the Facility and ensure HIGHLAND can safely access the Facility at all times.
- 2.8 Maintain in full force and effect all existing policies of property and general liability insurance pertaining to the Facility in the minimum amount of \$500,000. Owner will furnish Highland with certificates of insurance evidencing that policies providing the required coverages and limits are in full force and effect at all times during the term of this Agreement.

SECTION 3

PAYMENT

- 3.1 The Owner shall pay HIGHLAND a monthly fee of **\$ 9203** for the labor involved in providing the services set forth in Section 1. Payment of this monthly service fee is due on the eleventh day of the month.
- 3.2 In addition to the fee set forth in Section 3.1, Owner shall pay for materials used by HIGHLAND on Owner's behalf in connection with the maintenance services set forth above. These fees include any required sampling, chemicals as well as discharge permit application processing. All such charges shall be listed on the invoice separate from the above maintenance service. Charges for materials will be at cost of such materials to Highland, plus 15% of that cost.
- 3.3 Owner agrees to pay all additional charges resulting from any services of HIGHLAND requested or required by Owner or State or Federal regulatory agencies. Such additional charges will be invoiced by HIGHLAND and payment from Owner will be due upon receipt of such invoices.
- 3.4 If any fees charged by HIGHLAND are not fully paid within 30 days of the invoice date, the unpaid balance shall accrue interest at 1.5% compounding monthly until paid in full. Owner will not be entitled to set off or reduction in service fees or other amounts due to any alleged default or breach by HIGHLAND or otherwise. Any unpaid balance greater than 90 days will be turned over for collections.



SECTION 4

LIMITATIONS OR LIABILITY AND INDEMNITY

- 4.1 Owner shall be exclusively responsible for, and HIGHLAND will have no liability for all losses, expenses, damages or claims resulting from bodily injury, damage to property, or destruction of property arising out of, or in connection with, the performance of this Agreement, except that Owner shall not be liable for claims caused by HIGHLAND's willful misconduct or sole negligence.
- 4.2 Owner agrees to indemnify and hold harmless HIGHLAND and its employees, officers, directors, members, owners, managers, and agents, from and against any and all liabilities, losses, costs, expenses, and obligations, including, without limitation, reasonable attorneys' fees, court costs, and other expenses arising out of or relating to any breach of this Agreement by Owner or any negligent acts or willful misconduct by Owner in connection with the Facility.

SECTION 5

TERM

- 5.1 This Agreement shall start on March 1, 2026, and terminate in one year or renew automatically on an annual basis unless terminated in writing by either party. Upon each annual renewal, the monthly fee under this Agreement will increase by COLA unless otherwise agreed to in writing by the parties.
- 5.2 Either party may terminate this Agreement with 7 day's notice.
- 5.3 Upon any expiration or termination of this Agreement, all outstanding service fees and other amounts owing by Owner to HIGHLAND will immediately become due and payable to HIGHLAND by Owner. In addition, HIGHLAND and Owner will continue to perform any obligations accrued prior to such expiration or termination, including payment by Owner of service fees accrued or arising prior to the expiration or termination of this Agreement. If legal action is required to recover any amounts due for services under this Agreement, HIGHLAND shall be entitled to reasonable costs and attorney's fees.

SECTION 6

REPRESENTATIVE AND WARRANTIES OF OWNER

- 6.1 Owner represents and warrants to HIGHLAND that:
- 6.2 Owner is and during the term of this Agreement will be organized and validly existing as a corporation or company in good standing and lawfully doing

business in the State of Michigan and has the power and authority to own, operate, and use the Facility.

- 6.3 Owner has the power and authority to execute, deliver, and perform this Agreement and has complied with and during the term of this Agreement will be in compliance with all obligations under the Permit. This Agreement has been executed and delivered by Owner and is a valid and binding obligation of Owner,

enforceable against it in accordance with its terms. Should Owner sell or transfer obligations of Facility, Owner will remain responsible for any services, materials or labwork completed prior to sale or transfer date.

SECTION 7

NOTICE

- 7.1 This Agreement constitutes the entire agreement and understanding between HIGHLAND and Owner and supersedes all offers, negotiations, and other agreement concerning the subject matter contained herein. AGENDA TOPIC: CES Proposal for Design and Permitting for Sanitary Sewer for Morningdale Drive

TOPIC EXPLANATION: During the original design and installation of sanitary sewers in the Island / Briggs Lake area in 2004, there was limited support for extending sewer service to parcels located off Academy Drive. Since that time, a handful of homes have experienced failing septic fields. Those homes were located close enough to Academy Drive to allow connection to the existing system through grinder pump service leads.

We now have one home with a critically failed septic field and another nearby residence requesting sanitary sewer service. The distance from the existing low-pressure main exceeds what can be reasonably accommodated by a grinder pump service lead, and it is impractical to install multiple long service leads within the road right-of-way.

Because sanitary sewer service is available in the area, the Livingston County Health Department will not permit repairs or replacement septic fields. As a result, it is only a matter of time before each of these homes will be required to connect to the sanitary sewer system.

I am proposing to fund this out of the sewer fund 490-000-806.000

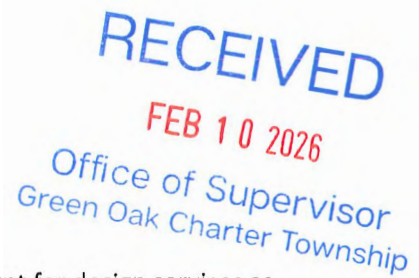

The Client and Civil Engineering Solutions, Inc. (CES) enter into this agreement for design services as described below. The parties agree as follows:

PROJECT DESCRIPTION: Layout and Sizing of a Low-pressure Sewer along Morningdale Drive to Edgewood Drive within the Island Lake Colony Subdivision, Green Oak Charter Township (Township.)

PROJECT UNDERSTANDING:

CES was requested to attend an on-site meeting with the Green Oak Township Supervisor to discuss options for installing a low-pressure sewer along Morningdale Drive to provide sanitary sewer service to the resident of 6663 Morningdale Drive that has a failed septic tank and tile field system. The meeting occurred on June 3, 2025 and was attended by Mr. Rick Miner (Rick), P.E, Senior Project Manager, CES. The primary purpose of the meeting was to discuss issues associated with the property's failed septic system and how to economically extend sanitary sewer service to the subject parcel and the nearby properties.

In preparation of the meeting the Green Oak Township Supervisor, Mr. Mark St. Charles (Mark) arranged to have the existing low-pressure sewer field located by the Township's utility locating service so that it would be possible to visualize the pipe location for the on-site meeting. Unfortunately, the existing low-pressure sanitary sewer pipe's diameter is currently unknown. Based on the results of the on-site meeting with Mark, and the utility location work, it was determined that the location of the existing low-pressure sanitary sewer extended to approximately the southwest corner of Lot No. 228 of the subdivision.

On January 8, 2026 Rick met with representatives of D'Angelo Brothers Excavating, Inc. and Highland Treatment, Inc. to primarily to discuss options for installing a grinder pump in the backyard of the 6663 Morningdale Drive property and to also review the remaining portion of the Morningdale Drive to better understand the difficulties of extending the low-pressure sewer further along Morningdale Drive to Edgewood Drive.

In preparing this scope of services for this project, our internal research leads us to believe that the existing "low-pressure sewer" that currently exists along Morningdale Drive from Academy Drive easterly to 6674 Morningdale Drive is likely a grinder pump lead and not a low-pressure sanitary sewer. We are of this opinion since there appear to be no records of a low-pressure sewer being installed in this area. We believe it to be unlikely that no records would exist for such an installation. Also, based on correspondence from 2017, between CES Staff and Green Oak Township Staff, it appears that Green Oak Township was unaware that the resident of 6674 Morningdale Drive had sanitary sewer service and was connected to the existing low-pressure sewer within Academy Drive. In addition, it seems unlikely that a low-pressure sanitary sewer would only be extended to 6674 Morningdale Drive and not further along the roadway where it could serve additional units. Based on the above information, it is our belief that these facts are consistent with the existing piping along Morningdale Drive most probably being a private grinder pump lead and not a low-pressure sanitary sewer.

Based on the above information, CES provides the following scope of services to design a low-pressure sewer to be installed by horizontal directional drilling methods from Academy Drive to the intersection of Morningdale and Edgewood Drives.



The proposed scope of services has been prepared such that it is assumed that Green Oak Township will present the provided plan and profile drawings to its On-call Contractor, D'Angelo Brothers Excavating, Inc., for them to provide a price quotation for the work based on their existing and agreed upon unit prices for the work. The prepared plans will also allow Green Oak Township Staff to provide the completed plans to other local underground utility contractors for them to provide price quotations as well. It is our understanding that CES **is not** to provide contract documents or other services needed to allow this work to be publicly advertised and competitively bid.

SCOPE OF WORK:

The proposed scope of work for this project includes the following tasks to be performed by CES:

- Coordination and scheduling of CES's Surveyor to obtain detailed topographic information relating to the proposed project work area; obtaining the precise location of the existing property lines, lot lines, and existing easements of the areas surrounding the expected project work area (see survey Exhibit Drawing for the planned limits of the proposed survey). We request that Green Oak Township has its utility locating service flag and mark the location of the existing piping in Academy and Morningdale Drives to provide the best available information for the project;
- Process all obtained topographic survey data and the preparation of the necessary base drawings on which the project's design can be based. CES will also coordinate with the MISS-DIG network and request a MISS-DIG design ticket. CES will review all data obtained from the known public utilities in the area and will include this information on all drawings created as part of this project's work;
- CES will incorporate the information obtained from the MISS-DIG Design Ticket process into the plans for the project. However, based on our past experience, and with the level of information that is typically provided, we expect that it will not be possible to accurately locate all existing utilities on the plans. Specifically, underground telephone, cable TV, and fiber optic internet lines, among others, are very difficult to ascertain their precise location. CES will locate the underground facilities to the best of their ability based on the provided information, but we **cannot** make any warranty, express or implied, of the accuracy of the existing underground utility locations;
- Create one (1) Plan and Profile Drawing at a scale of 1" = 30' Horizontally and 1" = 3' Vertically that contains the relevant project information and site features. Our review of the site indicates that the constructable area along Morningdale Drive is narrow and tree-lined. Consequently, our design will be prepared such that the proposed low-pressure sanitary sewer will be placed at or near the center of the existing roadway. This will expedite the construction and reduce the need for any easements associated with the proposed construction, however the future extension of other underground utilities may be impacted;
- Research the configuration of the existing grinder pump lead and/or low-pressure sanitary sewer along Morningdale Drive to determine if the inclusion of an Air-relief Valve or Intermediate Flushing Connection is needed. Based upon the information that we currently have, it may not be possible to find reliable information regarding the existing grinder pump lead and/or low-pressure sanitary sewer. Consequently, as part of the construction plan requirements, it will, most probably, become necessary to direct the Contractor to perform exploratory excavations to determine the horizontal and vertical location, as well as, the diameter of the existing piping prior to the commencement of construction activities. Our plans will be prepared in such a manner so that a low-pressure sewer of an appropriate diameter can be installed from Academy Drive to Edgewood Drive as part of the project. If it turns out that the existing piping is in fact a low-pressure sanitary sewer, then the project limits can be reduced during construction;



- Perform the calculations needed to size the proposed low-pressure sanitary sewer. As part of this work, CES assumes that the proposed pipe will only service the existing homes along Morningdale Drive and that the low-pressure sanitary sewer along Morningdale Drive will not be utilized as a future force main that has other neighboring areas routed through it;
- Review the preliminary design with the Green Oak Township Officials and its Sanitary Sewer System Operator to obtain their concurrence that the proposed design is adequate. CES will revise the construction plan one-time based on the comments received;
- Prepare and submit the required EGLE Part 41 Sanitary Sewer construction permit. CES will revise the drawing as needed to obtain the required permit;
- CES will prepare, and provide to the Township, the following construction plan sheets as part of the final deliverables of this project:
 - Cover Sheet
 - Legend/Construction Note Sheet reflecting the project's unique conditions and requirements
 - Plan and Profile drawing of the proposed low-pressure sewer
 - Required Soil Erosion and Sedimentation Control Measures and plan details
 - Estimated Construction Quantities (to be included on the appropriate plan sheets)
 - Standard Construction Details reflecting the requirements of Green Oak Township and its sanitary sewer system

Construction Administration services of any form are not included in this scope of services. If the Township requests assistance during construction, CES will provide those services on an hourly basis at our current agreed upon hourly rates with the Township.

FEES AND INVOICING: The fee to provide the scope of services is outlined below and as shown in the attached breakdown:
