Local Dems are trying to play the race card on me . . .

I received a request from Jon King of WHMI radio to comment on a Facebook post. The post implied that I condone white supremacy.

Nakagiri is also the campaign manager for Ann Bollin for State Representative . . ." In her same Facebook post Ms. Helton added, "We demand and deserve better leadership, and I feel as though Wes should be called to answer for this post in the public sphere."

If Ms. Helton, a former journalist, would have published these assertions at her old newspaper she clearly would have been guilty of journalistic malpractice, or in today's vernacular, "fake news." Had Ms. Helton contacted me I would have set the record straight for her. But as is the case in much of our politics today, many are more interested in scoring cheap political points rather than having a truly civil dialogue about important issues of the day.
